## ENTRY CONDITIONS – ALBUM

- **ONLY BLUES MUSIC WILL BE ACCEPTED.**
- The Act representative entering the album (1 person) must be a financial member of the Melbourne Blues Appreciation Society.
- **The album must have been commercially released between 1 October 2023 and 30 September 2024.**
- The album must comprise a minimum of 10 tracks OR at least 35 minutes of music.
- The album must have been commercially pressed in a run of at least 500 copies OR an internet release via a recognised internet distribution channel such as iTunes, Spotify, etc.
- The album must contain at least 50% previously unreleased material.
- Albums must be submitted in CD version (**only ONE CD copy required**).
- The album must have been either recorded or mixed or mastered in Victoria.
- **The performing artist must be a Victorian or Tasmanian resident.**

## ENTRY CONDITIONS – SONG OF THE YEAR

- **ONLY BLUES MUSIC WILL BE ACCEPTED.**
- The composer of the music submitted must be a financial member of the Melbourne Blues Appreciation Society.
- **The song must have been recorded between 1 October 2023 and 30 September 2024 (not necessarily commercially released).**
- Song must be submitted in CD version (**only ONE CD copy required**).
- The song must have been either recorded or mixed or mastered in Victoria or Tasmania.
- **The performing artist must be a Victorian or Tasmanian resident.**

## ELIGIBILITY

**TRIO/BAND:** A Victorian or Tasmanian act is one that contains members who are all currently resident in Victoria or Tasmania and have resided in Victoria or Tasmania for a minimum of one year.

**DUO:** In the case of a Victorian or Tasmanian duo, both members must have been resident in Victoria or Tasmania for a minimum of one year.

**SOLO:** A solo artist must currently reside in Victoria or Tasmania and have resided in Victoria or Tasmania for a minimum of one year.

**NOTE:** Guest artists appearing on your submitted recordings who are not residents of Victoria or Tasmania, are permitted, providing they are not the feature act.

## JUDGING

- Judging will only be considered on the basis of the recordings presented.
- There will be 5 blues music industry professionals as judges, independent of the MBAS, who will judge in isolation from each other.
- Judges are not obligated to score in a category if they deem the nominated album/song not suitable.
- Judges will score the nominated album/song on its own merits and not against other artists' albums/songs.
- The final arbiters of any disputes will be the MBAS Committee.
